4 **A CALL FOR THE UNITED CHURCH OF CHRIST TO TAKE ACTIONS TOWARD A**  
5 **JUST PEACE IN THE ISRAELI-PALESTINIAN CONFLICT**  
6

7 **Submitted by New Hampshire Conference**  
8 **A Resolution of Witness**  
9

10 **SUMMARY**  
11

12 This resolution proposes a fourfold strategy by the United Church of Christ to help end  
13 the ongoing Israeli-Palestinian conflict. It includes “calls” that seek to establish a just  
14 peace: 1) A call to study the 2009 Kairos Palestine document, *‘A Moment of Truth’: A*  
15 *Word of Faith, Hope, and Love from the Heart of Palestinian Suffering*; 2) a call to  
16 United Church of Christ entities to divest holdings from companies profiting from the  
17 occupation of Palestinian territories; 3) a call to all entities of the United Church of Christ  
18 to boycott goods produced by Israeli companies in the occupied Palestinian territories;  
19 and 4) a call to request Congress to investigate whether U.S. military aid given to Israel  
20 violates U.S. laws.  
21

22 **BIBLICAL, THEOLOGICAL AND HISTORICAL GROUNDING**  
23

24 This resolution is grounded in the Biblical prophetic call to do justice and the decisive  
25 embodiment of that call in Jesus Christ. It springs from the Affirmation of the 15<sup>th</sup>  
26 General Synod that the United Church of Christ is a Just Peace Church. That affirmation  
27 commits the United Church of Christ to enacting “solidarity with the poor, seeking to be  
28 present in places of oppression, poverty, and violence, and standing with the oppressed in  
29 the struggle to resist and change . . . evil.” It thereby commits the United Church of  
30 Christ to be both “a community of resistance, standing against social structures  
31 comfortable with violence and injustice,” and “a community of political and social  
32 engagement, in regular dialogue with the political order.”  
33

34 In addition, the United Church of Christ has historically stressed the importance of living  
35 out a Covenantal theology, whereby diverse autonomous organizations covenant to  
36 collaborate for the common good. Through such Covenantal relationships, the United  
37 Church of Christ partners globally with those most impacted by the continuing conflict  
38 between the Palestinians and Israel. The current list of thirteen Global Ministries Middle  
39 Eastern partners includes regional groups as well as Israeli and Palestinian groups,  
40 notably Kairos Palestine.  
41

42 Informed by that Just Peace commitment and Covenantal theology, this resolution seeks  
43 to respond to the theological declaration of our Christian partners in the Middle East that  
44 we are at a Kairos moment—a special opportunity provided by the “Still Speaking God”  
45 for us individually as Christians and collectively as a church both to listen to the  
46 Palestinian people courageously voice faith, hope, and love in the midst of their suffering  
47 and to respond with action.

48

49 Such listening and response is thoroughly in keeping with various historical (and  
50 historic!) United Church of Christ resolutions and actions concerning the Israel-  
51 Palestinian conflict:

52

53 The United Church of Christ has affirmed the right of Israelis and  
54 Palestinians to live peacefully within internationally recognized  
55 borders.

56

57 The United Church of Christ has identified Israel’s occupation of  
58 Palestinian land and the human rights abuses it has committed there  
59 to be a major source of conflict and has called for an end to settlement  
60 activity.

61

62 The United Church of Christ has a long history of effectively  
63 supporting boycotts against products produced under unjust  
64 conditions (lettuce, grapes, infant formula, etc.) and policies that  
65 produce such conditions (apartheid).

66

67 The United Church of Christ has had, since the passage of the 2005  
68 resolution on economic leverage, a strong history of corporate  
69 engagement with companies that profit from the Occupation.

70

71 **MUTUAL ACCOUNTABILITY**

72

73 The desired outcome is a just peace in the Israeli-Palestinian conflict. The hope is that  
74 individuals, churches, and church entities will learn of the present plight of the  
75 Palestinians, will study the history of the conflict, will examine their own consciences,  
76 and will engage in individual and institutional actions to pressure the government of  
77 Israel to end the Occupation as a step toward a just peace. At the same time, the call is to  
78 address members of our own government and ask them to ensure that U.S. aid to Israel  
79 complies with applicable U.S. laws.

80

81 Those stakeholders most directly affected are the Palestinians. The originators of the  
82 resolution, the United Church of Christ Palestine/Israel Network, have consulted with  
83 United Church of Christ's Global Ministries partner, Kairos Palestine, and with the  
84 movement that represents a wide coalition of the largest Palestinian organizations, trade  
85 unions, networks, and NGOs. Both enthusiastically support the resolution, as do  
86 Palestinian groups within the United States. Many groups in other Christian  
87 denominations and in the Jewish community also support this resolution.

88

89 The originators have also approached the two major United Church of Christ financial  
90 entities addressed by the divestment call – United Church Funds and the Pension Boards  
91 – United Church of Christ, Inc.

92

93 The United Church of Christ Palestine/Israel Network has consulted with staff from  
94 United Church Funds and has been in dialogue with them over the past six months. In  
95 addition, a member of the United Church of Christ Palestine/Israel Network Steering  
96 Committee has been welcomed to the meetings of the Ecumenical Action Group, which  
97 has been working on corporate engagement with some of the companies named in the  
98 resolution for the past nine years. None of the American companies named has  
99 responded to shareholder pressure to disengage from its support of the Occupation. Two  
100 of the international companies have taken steps to or made announcements that they  
101 would remove their operations from the occupied territories, but they have not yet fully  
102 done so. United Church of Christ Palestine/Israel Network is committed to continued  
103 dialogue about the best way to make investment/divestment decisions and welcomes a  
104 mechanism for establishing standards by which to make such decisions in the future.

105 United Church of Christ Palestine/Israel Network has also attempted to dialogue with the  
106 Pension Boards – United Church of Christ, Inc. on the divestment issue. Thus far, its staff  
107 has not been willing to engage in dialogue on the topic. Its executive has stated on the  
108 basis of legal opinion that its fiduciary responsibilities do not allow it to make  
109 investment/divestment decisions in response to Synod votes. Nevertheless, it has  
110 responded to the 2005 Synod "Economic Leverage" resolution by investing in the Siraj  
111 Fund, which supports nineteen Palestinian companies. Although this is indeed a positive  
112 step in support of the Palestinian economy, it does not acknowledge Israel's complete  
113 control over that economy and all its resources as documented by the World Bank.

114 Therefore, it cannot be viewed as an effective step toward ending the Occupation.

115 Finally, this resolution recognizes that members of the Jewish community with whom we  
116 have had long standing interfaith relationships are also stakeholders. It commends those  
117 relationships and calls for them to continue and expand.

118

119 Action Steps

120 Studying the *Kairos Palestine* document individually and in church groups

121 Encouraging travel to the region with Global Ministries and other alternative  
122 travel groups  
123 Sponsoring local educational conferences  
124 Self-examining investment portfolios by individuals, churches, conferences,  
125 and national United Church of Christ entities to discern whether and how  
126 divestment may be effectuated  
127 Working side by side with allied organizations in local communities to initiate  
128 and support boycott actions  
129 Writing letters and petitions, as well as making visits, to members of Congress  
130 in cooperation with Justice and Witness Ministries or other peace groups  
131 Initiating or continuing interfaith dialogues at all levels  
132

#### 133 Evaluation Plan

134 The resolution asks the General Minister and President to provide the whole  
135 church an annual assessment on the implementation of the resolution. United  
136 Church of Christ Palestine/Israel Network will offer a report on actions in the  
137 wider church that may be of assistance in developing that assessment.  
138

#### 139 **INSTITUTIONAL CAPACITY**

140  
141 The Officers of the Church, in consultation with appropriate ministries or other entities  
142 within the United Church of Christ, will determine the implementing body for each of the  
143 four components addressed in the resolution (elucidated above in the section entitled  
144 Summary), with the funding to be made in accordance with the overall mandates of the  
145 affected agencies (primarily the United Church Board, Global Ministries, and Justice and  
146 Witness Ministries) and the funds available to these agencies, keeping in mind that many  
147 of the actions will be taken by individuals and congregations of the United Church of  
148 Christ.  
149

150 In addition, Global Ministries, the joint witness of the United Church of Christ and  
151 Disciples of Christ for international peace, reconciliation, and justice, will be invaluable  
152 in implementing the resolution as it works to nurture existing partnerships in the region.  
153 Its efforts will be enhanced by the June 2015 launch of its eighteen-month Middle East  
154 Initiative.  
155

156 Moreover, the United Church of Christ Palestine/Israel Network, supported by its own  
157 budget, will continue to broaden its work of educating local churches and conferences.  
158

159 Taking all the aforementioned into account, it is clear that the United Church of Christ is  
160 currently well-equipped to implement easily this resolution.

161

162 **PROBABILITY OF INFLUENCING SOCIAL CHANGE**

163

164 With the adoption of this resolution, the 30th General Synod of the United Church of  
165 Christ will secure its rightful place alongside other denominations and peace-seeking  
166 groups in the United States and around the world that are taking a public stand against the  
167 occupation of Palestinian territories by the Israeli government while promoting the  
168 human rights of the Palestinians and opposing the use of violence by either party.

169

170 The unresolved Israeli-Palestinian conflict is of world-wide concern and has the potential  
171 to influence many other issues, including the safety of U.S. citizens here and abroad. The  
172 United Church of Christ has not addressed this conflict via resolution since 2005; yet  
173 political realities have changed drastically in the interim. Israel's occupation of  
174 Palestinian territories has become increasingly entrenched; settlements have grown  
175 exponentially; four massive attacks have been carried out on Gaza; and several attempts  
176 at the "peace process" have failed to resolve the conflict. Frustration with the lack of  
177 progress has contributed to escalating violence from both sides.

178

179 Meanwhile, Palestinian Christians have issued their *Kairos Palestine 2009 – "A Moment*  
180 *of Truth"* document, and Palestinian civil society has endorsed a movement calling for  
181 boycott, divestment, and sanctions. That movement is now world-wide and has achieved  
182 some notable successes, particularly in Europe but also in the U.S., including the loss of  
183 \$26 million in contracts by Veolia, the divestment from Israeli banks by European banks  
184 and pension funds, and the loss of revenue by SodaStream. Recently, Kuwait announced  
185 the termination of contracts with companies complicit in the Occupation and Sweden  
186 recognized the State of Palestine. In addition, most of the mainline Protestant  
187 denominations in the U.S. have been considering resolutions that call for some form of  
188 boycott and/or divestment. Indeed, local Presbyteries, Episcopal Dioceses, and Methodist  
189 Conferences have voted to boycott or divest. Most notably, the Presbyterian General  
190 Assembly voted in 2014 to divest from three companies.

191

192 By approving this resolution with its clear, unequivocal call for specific actions toward  
193 ending the occupation of Palestinian territories, the United Church of Christ can offer a  
194 sign of hope to the Palestinians and add its weight to a world-wide movement toward a  
195 just peace in the region.

196

197 United Church of Christ Palestine/Israel Network has been presenting workshops and  
198 study sessions on this issue in local churches, associations, and conferences since its  
199 inception in January 2012 and will continue to do so. The consideration of this resolution  
200 in five United Church of Christ conferences and its acceptance as a study document in

201 two more conferences have led to an enormous amount of discussion and education in  
202 those conferences. Without a resolution with specific action components, such  
203 engagement would not have occurred. The consideration of the resolution by the Synod  
204 opens this conversation to the wider United Church of Christ.

205

206 **TEXT OF THE MOTION**

207

208 The psalmist celebrates, “How good it is when brothers and sisters dwell together in  
209 unity” (Psalm 133). Yet today the Middle East is torn by disunity between Semitic  
210 brothers and sisters separated by “dividing walls of hostility” (Ephesians 2:14). We hear  
211 the call of the prophet Micah, “And what does the Lord require of you but to do justice,  
212 and to love kindness, and to walk humbly with your God?” (Micah 6:8).

213

214 As disciples of Jesus, we hear and seek to heed his call to be peacemakers: responding to  
215 violence with non-violence and extending love to all. In the words of our Palestinian  
216 Christian partners in *Kairos Palestine*, “True Christian theology is a theology of love and  
217 solidarity with the oppressed, a call to justice and equality among peoples.” (*Kairos-*  
218 *Palestine 2009: A Moment of Truth*)<sup>1</sup>

219

220 THEREFORE, in the spirit of the ancient prophets and the ministry of Jesus, we offer this  
221 resolution:

222

223 WHEREAS, in 1985 the Fifteenth General Synod of the United Church of Christ  
224 committed itself to be a Just Peace Church;<sup>2</sup> and at its 2003 Annual Meeting the New  
225 Hampshire Conference committed itself to be a Just Peace Conference;

226

227 WHEREAS, historically the United Church of Christ has affirmed Israel’s right to exist  
228 within secure and internationally recognized boundaries (GS 16 [1987]<sup>3</sup>, GS 18 [1991]<sup>4</sup>),  
229 and asserted the rights of Palestinians to enjoy sovereignty in an independent, contiguous,  
230 and viable state of their own, within secure and recognized boundaries (GS 16 [1987], GS  
231 17 [1989]<sup>5</sup>, GS 18 [1991]);

232

233 WHEREAS, past General Synods have identified the Israeli Occupation of Palestinian  
234 land and its human rights abuses committed therein to be a major source of conflict and  
235 have called for the end of the construction and expansion of settlements (GS 18 [1991],  
236 GS 21 [1997]<sup>6</sup>);

237

238 WHEREAS, the United Church of Christ is deeply committed to interfaith relationships  
239 and General Synods have confessed the sin of anti-Semitism and proclaimed its  
240 renunciation (GS 23 [2001]<sup>7</sup>) and have denounced actions against Islam or Muslims  
241 based on ignorance or fear (GS 28 [2011]<sup>8</sup>);

242

243 WHEREAS, the United Church of Christ values its relationships with Jewish groups in  
244 the U.S. who have differing perspectives on the conflict and with Jewish Israeli peace

245 activists who have sought justice, equality, and freedom for both peoples;

246

247 WHEREAS, the United Church of Christ recognizes the complexity of the conflict  
248 and that it has caused suffering for both Palestinians and Israelis;

249

250 WHEREAS, Palestinians in the West Bank have lived since 1967 under Israeli military  
251 occupation which subjects them to many human rights abuses, including loss of their  
252 land for the purpose of building Israeli settlements; limited access to their land and to  
253 each other due to the route of the Separation Wall on Occupied Palestinian Territory;  
254 being systematically pushed into small, noncontiguous geographic enclaves separated by  
255 barriers and checkpoints; gross inequality in the amount of water allocated to  
256 Palestinians; severe and arbitrary travel restrictions; limited access to holy sites;  
257 segregated roads; the demolition of homes; the destruction of Palestinians' crops by  
258 settlers and the Israeli army; arbitrary arrest, including the arrest of children<sup>9</sup>;

259

260 WHEREAS, the Israeli government subjects Palestinians in Gaza to military attacks  
261 using disproportionately overwhelming force; severe limits on personal entry and the  
262 entry of products essential to Gazans' well-being; a six-mile fishing limit in violation of  
263 international law; strict Israeli control of electronic communications, air space, and sea  
264 space; and the destruction of Gaza's infrastructure and economy;<sup>10</sup>

265

266 WHEREAS, Israel has annexed Palestinian East Jerusalem, separating it from the West  
267 Bank and Gaza, and subjects Palestinians of East Jerusalem to the appropriation of their  
268 properties for Jewish settlements, the denial of building permits, and the revocation of  
269 residency rights;<sup>11</sup>

270

271 WHEREAS, Israel refuses to end its occupation of territory conquered in the 1967 War,  
272 leading to numerous illegal actions and human rights abuses there by the Israeli  
273 government and military in defiance of United Nations resolutions,<sup>12</sup> and refuses to  
274 respect the Fourth Geneva Convention, as called for by the International Court of Justice  
275 in its opinion concerning the Separation Wall in the Occupied Palestinian Territory;<sup>13</sup>

276

277 WHEREAS, through the Kairos Palestine document of 2009 our Palestinian Christian  
278 partners, seeking an alternative to violence born of hopelessness and despair, have  
279 called on their global partners to engage in non-violent measures pressuring Israel to  
280 end its occupation;<sup>14</sup>

281

282 WHEREAS, the resolution "Concerning the Use of Economic Leverage in Promoting  
283 Peace in the Middle East," passed by the General Synod in 2005, called upon "the  
284 Covenanted Ministries, Pension Boards, United Church Foundation, local churches  
285 and members to use economic leverage, including, but not limited to: advocating the

286 reallocation of U.S. foreign aid so that the militarization of the Middle East is  
287 constrained; making positive contributions to groups and partners committed to the  
288 non-violent resolution of the conflict; challenging the practices of corporations that  
289 gain from the continuation of the conflict; and divesting from those companies that  
290 refuse to change their practice of gain from the perpetuation of violence, including the  
291 Occupation”;<sup>15</sup>

292

293 WHEREAS, despite years of corporate engagement and the submission of shareholder  
294 resolutions from United Church Funds<sup>16</sup> and other religious and secular groups, few  
295 companies have withdrawn any of their operations that support the Occupation;

296

297 WHEREAS, Jewish groups in the U.S. such as Jewish Voice for Peace<sup>17</sup> and American  
298 Jews for a Just Peace-Boston<sup>18</sup> as well as Israeli groups such as the Israeli Committee  
299 Against House Demolitions<sup>19</sup> and Coalition of Women for Peace<sup>20</sup> support the Boycott,  
300 Divestment, and Sanctions (BDS) movement against the Israeli Occupation;

301

302 THEREFORE BE IT RESOLVED, that the 30<sup>th</sup> General Synod of the United Church  
303 of Christ:

304

305 CALLS upon the churches and church members to study the Kairos Palestine document  
306 and take heed of its call for solidarity with the Palestinian people;<sup>21</sup>

307

308 CALLS upon the United Church of Christ Board, United Church of Christ Pension  
309 Boards, United Church Funds, Conferences, local churches, members, and other related  
310 United Church of Christ entities to divest any holdings in companies profiting from the  
311 occupation of the Palestinian Territories by the state of Israel, including, but not limited  
312 to, Caterpillar Inc., Motorola Solutions, Hewlett-Packard Development Company LP,  
313 G4S, and Veolia Environment and its subsidiaries;<sup>22</sup>

314

315 CALLS upon all entities of the church to boycott goods produced by Israeli companies in  
316 the Occupied Palestinian Territories, including, but not limited to, Ahava skin care  
317 products,<sup>23</sup> SodaStream products<sup>24</sup>, and Hadiklaim dates<sup>25</sup>, and upon church members to  
318 join boycotts in their local communities;

319 CALLS upon the United Church of Christ Officers of the Church and church members to  
320 request Congress to investigate whether U.S. military aid given to Israel violates U.S.  
321 laws, specifically, the U.S. Foreign Assistance Act and the U.S. Arms Export Control  
322 Act;<sup>26</sup>

323

324 CALLS upon the United Church of Christ Board to monitor the implementation of this  
325 resolution by all national United Church of Christ entities and to ensure that those who

326 manage the United Church Board’s own invested funds and provide United Church  
327 Board employee health and pension benefits are in compliance with the resolution; and  
328  
329 ASKS the General Minister and President to provide an annual report to the whole  
330 church on the implementation of this resolution.  
331

### 332 **FUNDING**

333  
334 The funding for the implementation of the Resolution will be made in accordance with  
335 the overall mandates of the affected agencies and the funds available.  
336

### 337 **IMPLEMENTATION**

338  
339 The Officers of the Church, in consultation with appropriate ministries or other entities  
340 within the United Church of Christ, will determine the implementing body.  
341
